TERMS AND CONDITIONS TO ENTRANTS OF RAFFLE

All entrants of the raffle benefiting C2Adopt Raffle ("Raffle") must be at least 21 years of age and a resident of the Commonwealth of Virginia. By entering the Raffle, you agree that you have read, understood, and are bound by these Terms and Conditions.

All Raffle entrants understand and agree that they are entering this Raffle to potentially win a one week stay at the Palmetto Cottage, a beautiful ocean front home at the Point on Emerald Isle. Your stay can be during an **available week between October 8, 2023 and May 19, 2024** (<https://reservations.emeraldislerealty.com/properties/palmetto-cottage>).

Reservation is subject to owner approval and must be made through owner. The winner is responsible for any linen charges, housekeeping, or related expenses. The Palmetto Cottage is a family home. It is not designed for house parties and the maximum number of guests permitted is twelve(12). The Winner is responsible for any and all damage to the premises, consistent with the Emerald Isle Realty rental policy. At least two individuals over the age of 30 must be present during the week. Exceptions will be considered at the owner's discretion.

Each Raffle ticket represents one Raffle entry. The cost of Raffle tickets is as follows:

- \$25+ level: 1 entry for every \$25 donated
- \$100+ level: 1 entry for every \$20 donated
- \$300+ level: 1 entry for every \$15 donated
- \$500+ level: 1 entry for every \$10 donated

There is no limit to how many tickets may be purchased at a time, or by any one individual. Tickets are non-refundable. You may enter the Raffle by purchasing ticket(s) online at <https://C2BFT23.givesmart.com>

A drawing selecting the Raffle winner will be conducted by an independent third party. Anyone who purchases a Raffle ticket, consistent with the terms and conditions set forth herein, is eligible to win, except for the Executive Director of C2Adopt.

Winner will first be notified by phone. A second attempt will be made via email. If unable to do so, a written notification will be sent to the address given at time of purchase. If C2Adopt is unable to contact the winner within seven (7) business days of the drawing, another winner will be selected. The winner agrees to report to the C2Adopt offices to provide valid identification and complete the necessary forms required by the IRS before the winner may receive permission to book the Palmetto Cottage. A record of all purchased and unsold tickets will be kept on file at the C2Adopt offices for three years.

C2Adopt requires that any and all winners are responsible for taxes related to receipt of a prize and may be required to pre-pay a portion of any tax liability prior to receiving the prize. C2Adopt cannot give any legal or tax advice related to this Raffle or receipt of a prize.
